- No electricity or security is provided.
- Exhibitors shall furnish their own tables, chairs and tent canopies.
- No refunds will be issued. Event held rain or shine.

By submitting this application, I assume all responsibility for my exhibit and hereby release Downtown Rhinelander Inc. and volunteers, the City of Rhinelander and Oneida County from claims of loss or damage of any kind. I hereby release and agree to hold harmless the DRI and volunteers, the event sponsor and its employees and volunteers, the City of Rhinelander and Oneida County from any damage to my property or any personal injury which I or my employees/helpers may sustain while participating.
